**PAYMENT TERMS:**

CHECK IS TO BE WRITTEN TO GASTON CONSTRUCTION, LLC., CASH, OR VENMO IS TO BE SENT TO (JGASTON10) FOR THE DUMPSTER RENTAL WHEN DUMP TRAILER HAS BEEN DROPPED OFF. CREDIT OR DEBIT CARDS ARE NOT ACCEPTED.

IF CUSTOMER IS NOT THERE AT THAT TIME, THEN CERTIFIED CASHIER'S CHECK IS TO BE WRITTEN TO GASTON CONSTRUCTION, LLC. OR CASH IS ACCEPTABLE FOR THE DUMPSTER RENTAL WHEN THE DUMP TRAILER HAS BEEN PICKED UP. CREDIT OR DEBIT CARDS ARE NOT ACCEPTED.

**DUMPSTER DELIVERY AND PICK UP TERMS:**

GASTON CONSTRUCTION, LLC. WILL DROP OFF DUMPSTER BEFORE 12:00 P.M. ON START OF RENTAL AGREEMENT DATE.

GASTON CONSTRUCTION, LLC. WILL PICK UP DUMPSTER AFTER 12:00 P.M. ON FINISH OF RENTAL AGREEMENT DATE. IF CUSTOMER WANTS TO EXTEND RENTAL PERIOD, THIS WILL BE INVOICED AT \$50/DAY. IF CUSTOMER OVERLOADS DUMPSTER OVER SIDE WALLS A \$50 OVERAGE FEE WILL BE CHARGED WHEN THE TRAILER IS PICKED UP. THIS OVERAGE FEE IS DUE TO THE RISK OF SECURING THE MATERIAL INSIDE THE DUMPSTER SO IT DOESN'T FLY OUT DOWN THE ROAD TO THE DUMP.

**LIABILITY:**

GASTON CONSTRUCTION, LLC. IS NOT TO BE HELD LIABLE FOR ANYTHING ELSE BESIDES DROP OFF, PICK UP, HAULING, AND DUMPING OF OUR DUMPSTER TRAILERS. CUSTOMER IS LIABLE FOR DUMPSTER TRAILER WHILE IT IS ON THEIR PROPERTY. IF FOR SOME REASON DUMPSTER TRAILER HAS TO BE MOVED FROM DROP OFF LOCATION THAN CUSTOMER TO CALL 404-626-4357. IF DUMPSTER IS MOVED BY CUSTOMER OR ANY OTHER PARTY AND DAMAGE IS CAUSED TO DUMPSTER TRAILER THAN CUSTOMER WILL BE INVOICED FOR DAMAGE CAUSED TO DUMPSTER TRAILER.

**BANNED MATERIALS:**

DIRT, CONCRETE, WET PAINT, OIL (ALL OTHER LIQUIDS), ASBESTOS, SEALED TANKS/DRUMS, ELECTRONICS (E-WASTE), AND TIRES. WE DO NOT ALLOW ANY OF THESE MATERIALS IN OUR DUMPSTERS THAT ARE FOR RENT. IF MATERIAL IS FOUND IN DUMPSTER, WE WILL TAKE IT OUT OF THE DUMPSTER AND LEAVE THE MATERIAL AT THE PROPERTY THAT THE DUMPSTER IS BEING RENTED AT.

**APPLIANCES:**

ALL APPLIANCES (DISHWASHERS, WASHERS, DRYERS, MICROWAVES, TVS, ETC. ARE TO BE LEFT NEXT TO DUMPSTERS. APPLIANCES WILL BE HAULED AWAY IN A SEPARATE LOAD. THEY ARE NOT TO BE PUT IN DUMPSTER WITH OTHER TRASH HAULING MATERIAL.
